Description:

A redundant freehold Methodist Church situated in the heart of the Golden Valley with lovely views over open countryside.

The Property:

The property comprises the original Church built in 1924 together with a more modern extension attached to the rear with kitchen and toilet facilities. The ceiling heights in the two parts of the building are approximately 4 metres and 2.6 metres.

The Church is surrounded by its own gardens and grounds, laid to lawn behind mature hedging. The rear property takes advantage of fine views over open countryside to the hills beyond.

Planning:

A Pre Planning Application was made to Herefordshire Council on 23rd May 2018 for the conversion of the Church to a residential dwelling. The Application has received a favourable reply which states that the information provided in the Pre-Planning Application would be supported as it meets the Council's Planning Policy. A full Application would need to be submitted to Herefordshire Council for formal consideration and Planning Permission.

A copy of the Council's letter and associated documentation are available from the Agents' Office and website.

Planning Permission for conversion would be as per the attached plans, however, we confirm this is only an Outline scheme and full Planning Permission has not been sought, therefore the proposed purchaser will need to submit their own definitive plans to Herefordshire Council.

Grave Stones:

To the best of our knowledge, there are no grave stones contained within the curtilage of the property.

Services:

Mains electricity and water.

Mode of Sale:

Prospective purchasers should carry out their own enquiries to Herefordshire Council and other Authorities before making an offer for the Church.

The contract and Connected Persons Certificate should be signed by the proposed purchaser(s) stating the proposed purchase price and should include a deposit cheque of 10% of the purchase price. To be received at the **Agents Office** by **Thursday 1st November 2018 at 12 noon**.

The deposit cheque should be made payable to 'MFG Solicitors LLP'.

At the time of submitting an offer all prospective purchasers should submit a cheque for the sum of 10% of their offer and all unsuccessful bidders will have their deposit cheque returned to them and unsuccessful contracts and documentation will be destroyed.

The owners will then confirm which, (if any), proposed offer to purchase is acceptable to them, the Solicitors will then immediately effect an exchange Contracts with a completion date of 13th December 2018 (or earlier by mutual agreement).

The Tender is legally binding. No further negotiations will be entered into after the Tender closing date.



