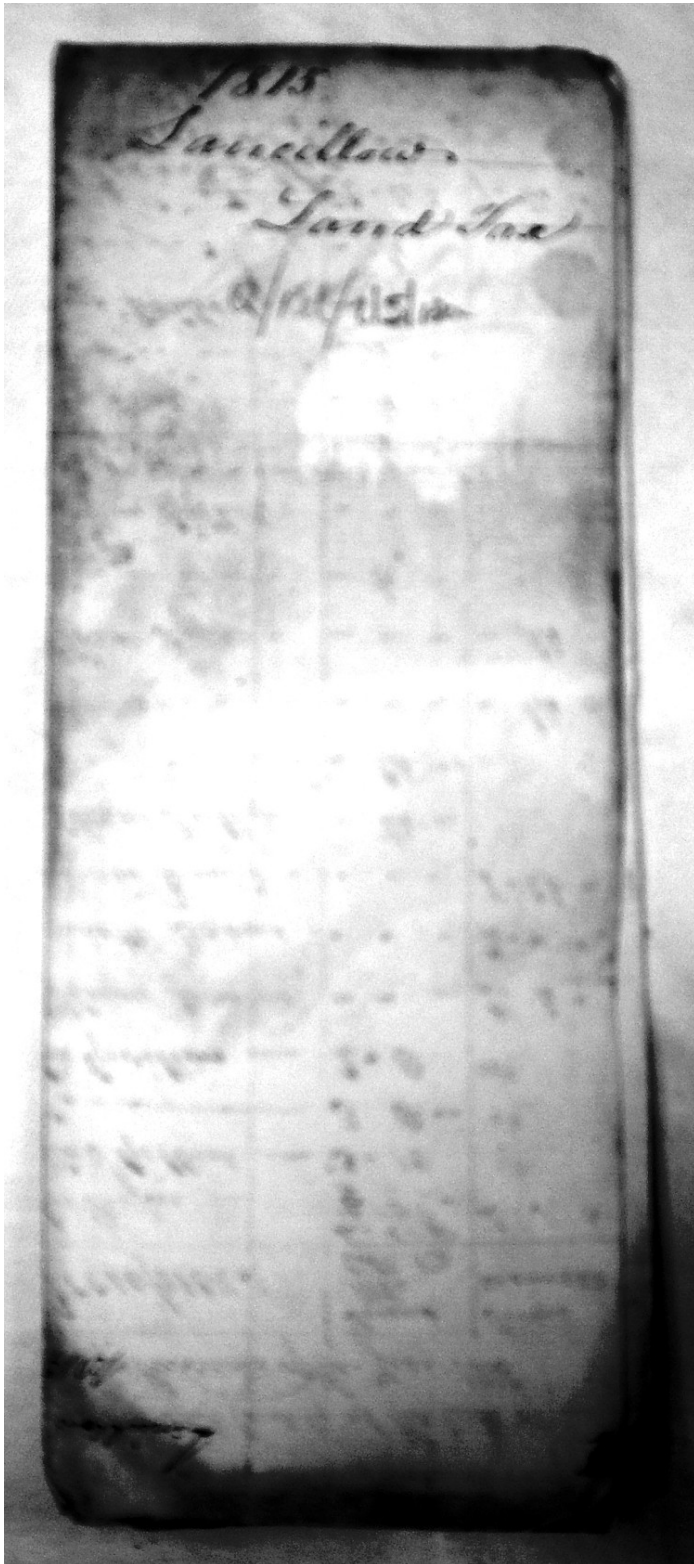

Description:

Photographs of the Land Tax records for Llancillo for 1815 to 1819 are shown below. Data for some individual years is not present in the archive, and may not have been originally recorded. The Land Tax Assessments show the names of the proprietor and occupier and the amount of the tax assessed, but the column on the forms intended to identify the property is generally either not filled in or contains a generic description such as 'message' rather than specific property names.
