Hope you had a good time with your family recently. Sorry to have missed the opportunity for an edifying exchange of historical information. However family must come first.

I've been doing more typing today and can now confirm an important quote concerning Tre Ysgallen.

Sir Trevor Williams Survey of Ewyas Lacy, at Gwent Record Office () has the following -

"The barony or manor of Trescaylond in Longtown, formerly the lands of Simon ap Harry Esquire & afterward of Rowland Vaughan Esquire and now in the hands of the lord of this manor was formerly held of the lords of this manor by the yearly rent of 13s 9d [4/2]?

5. To the fifth article, they say & present that there is within the boundary of the castle of Longtown one house which doth belong unto the said lords which is in good repair & held together with several parcels of lands by one Walter Jenkins amongst which parcels there is one ground called Rees Wall which they conceive to be demesne land. The house is the place where the lord's courts are usually held and so have been time out of mind. They likewise further say & present that there hath been an Old Castle at Walterstone & another at Trescaylond (now called Hunt House) now both clearly decayed And to what quantity, quality & yearly value thereof, they refer themselves to what is hereafter set down in this book.


Archaeology: Herefordshire SMR record 1464 notes a mount & ditch, 250 yds SSW Great Hunthouse, Longtown (SO 3430 2610). Details: 'A mound on SE border of parish, roughly oval and partly artificial, ¼ acre in extent, including defences. Flat top surrounded by dry ditch except on E and NE where the scarp abuts on a small stream and on SW where the ditches infilled. Traces of inner rampart on W. Feature ploughed out, site vaguely marked by rise of ground'.

Tithe Map and Apportionment: See Olchon Development Project, Field Name Survey, Longtown, p 64. Three properties in Longtown are listed separately from the township and borough: The Upper House, The Kevin and Lower House. The Upper House land consists of field numbers 1624-8 in the vicinity of modern Great Hunthouse and the same area as the archaeology noted above. This could be the location of Tre Ysgallen.


