
To the 4<sup>th</sup> Article the said Jury do on their Oath present and say that there are several Copyhold Tenants within the sd Manor that hold several customary lands or Tenements within the sd Manor grantable time out of mind to the several tenants of the same by Copy of Court Roll according to the custom of the sd Manor for the terms therein ment'd at the rents and services in their respective copies particularly ment'd and hereafter more particularly set forth to which the sd Jury do for more certainty before themselves and that upon the expiration of any of the said Copies the Lord of the Manor ought by the custom of the sd Manor to make a new grant thereof to the Tenant or Tenants thereof for the like term as before granted at a reasonable ffine & at the ancient Rent & services due & payable for the same And do further say that the said customary Lands and tenements and the right of renewall of the same by the custom of the said Manor are descendible to the heirs at Law of such Copyhold Tenants and not to their Exors or Adnims.

By the ancient custom of the Manor there is due to the Lord from any tenant seized with a freehold interest {except in Borough of Longtown and the Newcourt tenants} the following Heriotts

where there is no ancient Messuage or Messe place then five shillings
