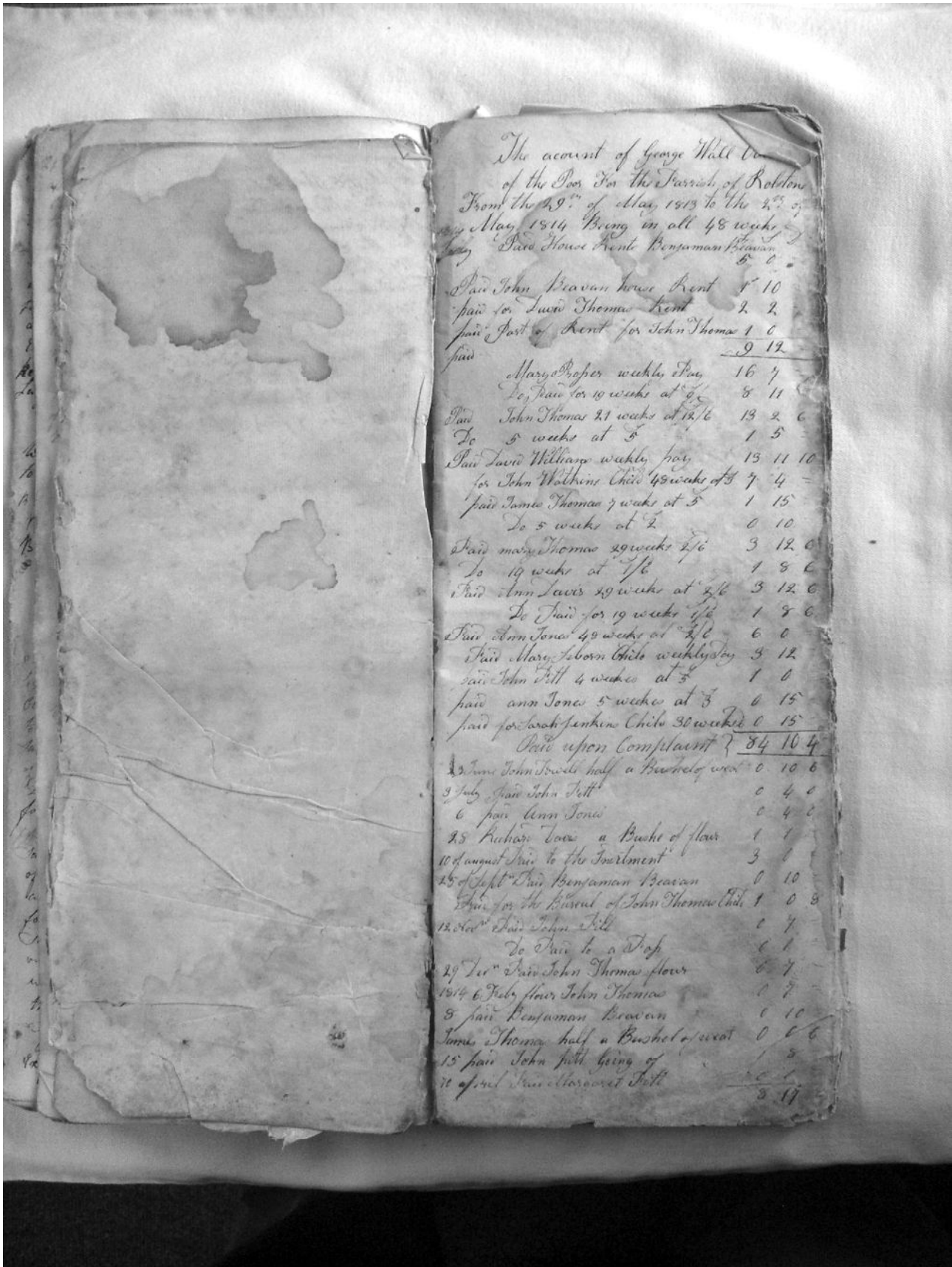

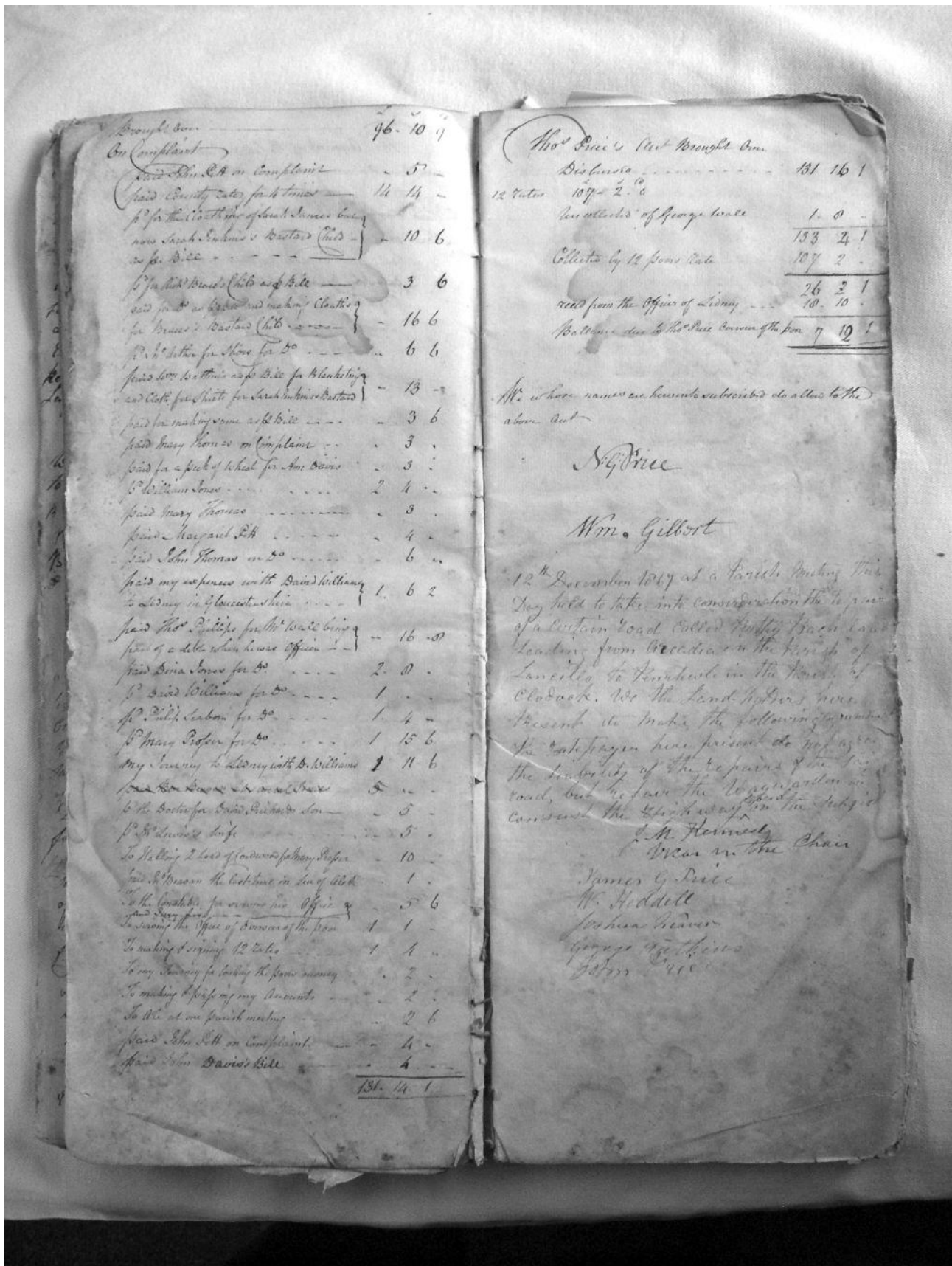

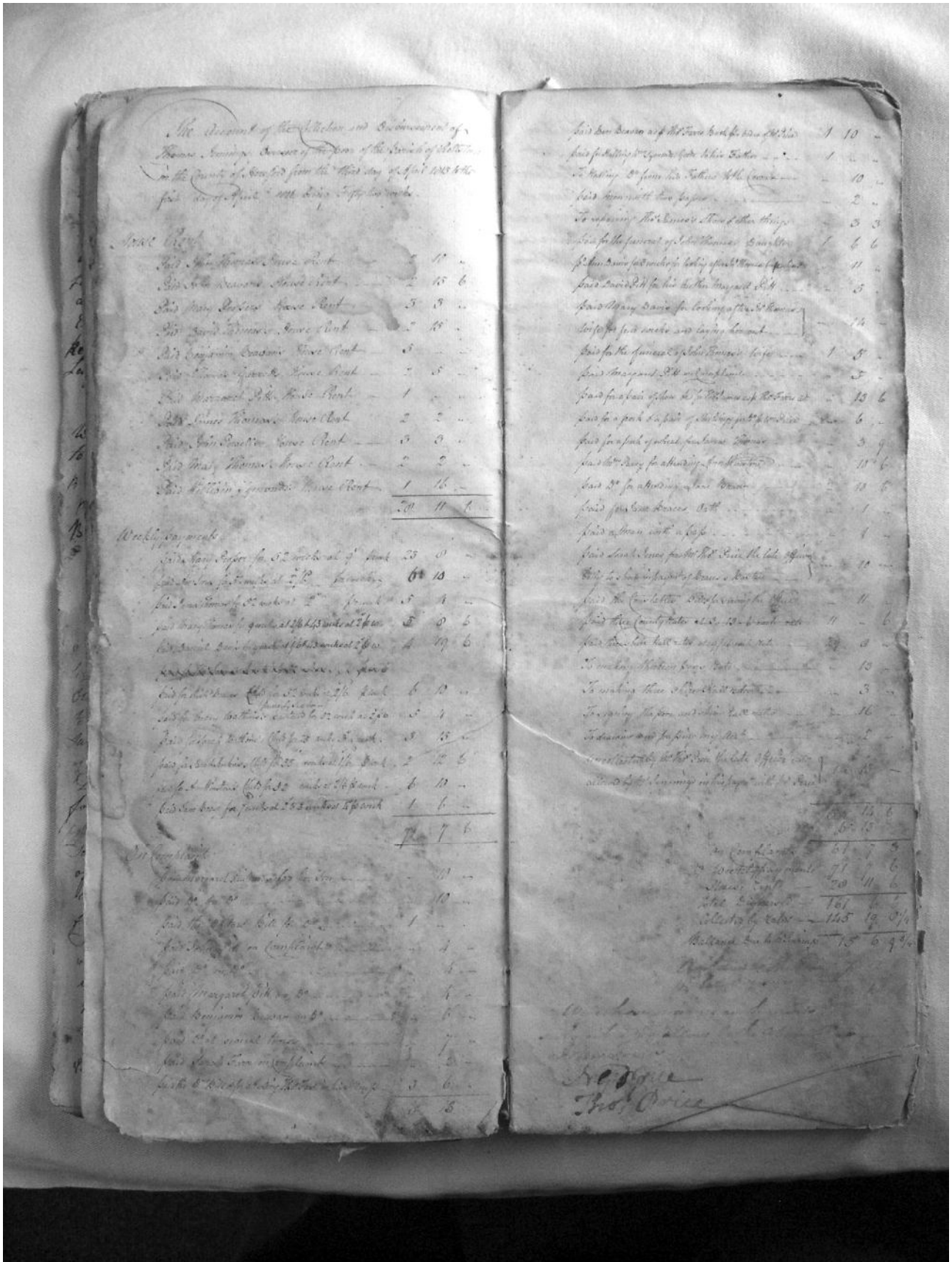

7 May 1817 A parish meeting held this day  
according to notice given on Sunday last  
by the overseers of the Poor of the Parish  
of Bowstone We the Landholders of  
the Parish do make the following order  
We do order and allow Thomas Powell  
£ for his house Rent also John Williams  
3/- towards his Do. We also agree  
with N. G. Price for the house and garden  
and the little govtree at Three guineas  
till May Day next We also allow the  
3 overseers an allowance of 6/- in the  
Round it being the second Rate  
We also agree to pull Mary Procter's  
down to ~~the~~ <sup>three</sup> Shilling per Week instead  
Six until further orders
