Appointees and assigns therein particularly set forth And
 it was in and by the said last mentioned Indenture agreed
 that the said David Lewis and Arnold George should
 surrender into the hands of the Lord according to the said
 custom, the said Customary or copyhold premises to the
 use of the said Walter Gilbert Price his heirs and assigns
 during the life of the said James George subject to such
 and the like proviso for making void the said surrender
 as was therein contained for reconveyance of the said
 freehold premises And whereas the last recited
 Indenture hath been this day produced to the Steward
 of the said Manor and appeared to have been duly
 executed and marked with the proper duty **Now**
know Ye that on the fifteenth day of February one
 thousand eight hundred and forty eight before me
 Baker Gabb Gentleman Steward of the said Manor at
 my Office situate in the town of Stergawenny in the
 County of Shropshire came the said David Lewis and
 Arnold George and for the considerations mentioned
 in the last mentioned Indenture did surrender
 into the hands of the Lord of the said Manor by
 the hands and acceptance of the said Steward
 by the rod according to the custom of the said Manor
 All and singular the said Copyhold Tenement
 Barn Stable Garden Orchard Fold and several
 pieces or parcels of land and other hereditaments
 and premises hereinbefore more particularly
 described and comprised in the hereinbefore recited
 Surrender of the ninth day of May one thousand eight
 hundred and forty to the intent that the said Lord
 might by the said Steward regrant the same premises
 with the appurtenances to the use of the said Walter
 Gilbert Price his heirs and assigns for the natural life of
 the said James George at the will of the Lord according to
 the custom of the said Manor subject to such and the
 like proviso for making void this Surrender as is contained
 in the said last mentioned Indenture for reconveyance of
 the said freehold premises Whereupon the said Lord
 by the said Steward according to the custom of the said
 Manor granted unto the said Walter Gilbert Price All
